# 1. ABOUT RHHF

Royal Heritage Health foundation (RHHF) is a Non-Governmental and not for profit Organization committed to creating a society where the poor and vulnerable have equal access to quality education, health, infrastructure and dignity of human person. RHHF is one of Nigeria Humanitarian Fund (NHF) Implementing Partners (IPs) in executing projects in Northeast Nigeria.

Gender Based Violence (GBV) continues to be a major protection concern facing IDP women and girls in north-east Nigeria coupled with the covid-19 pandemic which has further aggravated the already dire living conditions and the number of people in need of humanitarian assistance in north east Nigeria.

This project seeks to scale up GBV Protection, response and prevention services to the most vulnerable population through increased awareness of IDPs and high-risk communities on available services for GBV survivors as a form of prevention, risk mitigation, and response. It will also improve access to well-coordinated quality life-saving approach GBV services building on existing GBV interventions in high burden communities in Mubi North and Hong LGAs in Adamawa State.

In view of the above activities RHHF is to engage a vendor(s) who will provide radio Jingle programs and discussion to strengthen referral system, forensic and ethical investigations to enhance survivor friendly processes for justice and effective performance and to create awareness in Hong and Mubi North LGAs in Adamawa State.

### OBJECTIVE

The objective of the RFQ is to identify a supplier who can provide RHHF with the above-mentioned services. The selected vendor is expected to provide such service, based on specific Purchase Orders submitted to the vendor.

### **GENERAL INSTRUCTION TO SUPPLIERS:**

Description of Goods: RHHF request prospective suppliers to submit quotation for the items below:

 Radio Jingle and discussions to strengthen referral system, forensic and ethical investigations to enhance survivor friendly processes for justice and effective performance and to create awareness in Hong and Mubi North LGAs Adamawa State 20days per month for 3months, .

#### CORRUPT, FRAUDULENT, AND COERCIVE PRACTICES

RHHF requires that all RHHF Staff, manufacturers, suppliers or distributors, observe the highest standard of ethics du ring the procurement and execution of all contracts. RHHF shall reject

any proposal put forward by Suppliers, or where applicable, terminate their contract, if it is determined that they h ave engaged in corrupt, fraudulent, collusive or coercive practices. In pursuance

of this policy. RHHF defines for purposes of this paragraph the terms set forth below as follows:

I. Corrupt practice means the offering, giving, receiving or soliciting, directly or indirectly, of any thing of value to influence the action of the Procuring/Contracting Entity in the procurement process or in contract execution;

II. Fraudulent practice is any act or omission, including a misrepresentation, that knowingly or recklessly mislea ds, or attempts to mislead, the Procuring/Contracting Entity in the procurement process or the execution of a contract, to obtain a financial gain or other benefit to avoid an obligation;

Collusive practice is an undisclosed arrangement between two or more bidders designed to artificially alter th e results of the tender procedure to obtain a financial gain or other benefit;

III. Coercive practice is impairing or harming, or threatening to impair or harm, directly or indirectly, any participan t in the tender process to influence improperly its activities in a procurement process, or affect the execution of a contract

#### **CONFLICT OF INTEREST**

All Suppliers found to have conflicting interests shall be disqualified to participate in the procurement at hand. A Supplie r may be considered to have conflicting interest under any of the circumstances set forth below:

A Supplier has a relationship, directly or through third parties, that puts them in a position to have access to i nformation about or influence on the Quotation of another or influence the decisions of the Mission/Procuring Entity regarding this quotation process

A Supplier submits more than one Quotation in this Quotation process;

A Supplier who participated as a consultant in the preparation of the design or technical specifications of t he Goods and related services that are subject of this quotation process.

#### CONFIDENTIALITY AND NON-DISCLOSURE

All information given in writing to or verbally shared with the Supplier in connection with this General Instruction is to betreated as strictly confidential. The Supplier shall not shareor invoke such information to any third party without the p rior written approval of RHHF. This obligation will continue after the procurement process has been completed whether or not the Supplier is engaged.

#### RHHF'S RIGHT TO ACCEPT ANY QUOTATION AND TO REJECT ANY AND ALL QUOTATIONS

RHHF reserves the right to accept or reject any quotation and to cancel the

procurement process and reject all Quotations, at any time prior to award of contract, without thereby incurring an y liability to the affected Supplier/s or any obligation to inform the affected Supplier/s of the ground for RHHF's act ion.

#### **OVERVIEW OF EVALUATION PROCESS**

Quotations will be evaluated based on the compliance with the specifications stated and the total cost of the goods (price quote).

Following is the evaluation criteria for the quotations to be submitted:

- i. Company registration with Corporate Affairs Commission
- ii. Cost Effectiveness
- iii. Guaranty of Products
- iv. Business Reputation
- v. Price Validity

# 2. PAYMENT TERMS

100% Payment shall be made upon delivery of Commodities or Services and submission of due documents.

# 3. DELIVERY

All commodities and consumables ordered shall be delivered in full, No partial delivery except otherwise stated by the Procurement Manager or as specified in the Local Purchase Order.

# 4. BRIBING

RHHF has zero tolerance policy on gifts and hospitality. Suppliers are therefore requested not to send gifts or offer hospitality to RHHF personnel.

# 5. PSEA

All vendors that will be engaged shall take all appropriate measures to prevent sexual exploitation or abuse of anyone by it or any of its personnel or any other persons who may be engaged by the partner to perform any services under all RHHF related contracts.

For this reason, vendors shall refrain from any sexual activity with persons less than eighteen years of age regardless of consent or age of majority.

In addition, vendors shall refrain from exchange of money, goods and services for anything of value for sexual favors or any form of degradation.

• Supplies and provision of services will be based on local purchase order due to variances in training and locations.
